

Editor Limitations on Editing ORCID Information

In previous versions of EM, Editors with RoleManager permission (Search People) could use the Search People – Update Information page to fetch or manually enter a non-Authenticated ORCID identifier. This capability was retained because of the occasional situation when a publication needed to update a user record, but the user could not supply an Authenticated ORCID iD (i.e., the user was deceased).

In EM version 14.0, publications can further restrict this permission to specific Editor roles, rather than granting it to any Editor role that can search people. A new Editor RoleManager permission, Change ORCID iD, is added as a sub-permission to Search People.

This means that a user with an Editor role not granted the new permission is prohibited from entering or fetching an ORCID, thus eliminating the possibility of receiving unauthenticated ORCIDs into the system. For Editor roles that do not have the new permission, the Search People – Update Information page displays the ORCID field as



not editable (grayed out) and the Fetch and Delete links do not appear.

TO CONFIGURE:

For the Editor role(s) that should be granted the new permission, go to the Edit Role Definition page in **RoleManager**. In the Viewing and Editing People Data section, check the box to enable the Search People sub-permission, Change ORCID iD.

Over recent releases of EM, additional configuration options have been added to require users to authenticate ORCID identifiers before they are stored in the EM site and to prevent users from providing non-Authenticated ORCID identifiers for other users. Verify that these recommended **PolicyManager** settings are enabled in the Registration and Login Policies section:

- Edit Registration Fields: check the box, Require Users to Authenticate with ORCID.
- Configure Proxy Registration Fields: for the ORCID field check the box, Hidden.
